Laidley SHS Laptop Hire and EQUITY Hire Repairs

As part of these programs, students will have access to a Laidley State High School owned device that is connected to the school's network for internet access (with content filtering), network storage and printing services. While at home the device is able to be connected to the home network where it can access personal networks, internet and printing devices.

While the device is hired to a student it is important to understand that it is the responsibility of the student and family, and as such, any damages incurred will result in the student's account being invoiced for the cost of repairs.

As these devices are under warranty they cannot be repaired by an outside agency and must be returned to the school in order for a job to be logged with the manufacturer.

All devices owned by Laidley SHS will incur charges when being repaired. If the repair is deemed to be due to manufacturing fault there will be no charge.

Repair costs can vary depending on severity of the damage and typically range from \$50 to \$500.

Process for having a Laidley SHS Hire or EQUITY Hire laptop repaired

- 1. Complete a Laidley SHS IT Device Incident Report (available from the Resource Centre or the school website www.laidleyshs.eq.edu.au)
- 2. Take the completed form and device to the Laidley SHS IT staff (in the Resource Centre)
- 3. The device will be assessed by the IT staff and, if needs to be repaired by the manufacturer a copy of the quote for the repair will be provided to the parent/caregiver for their information prior to the laptop being sent for repair. Please note, that as the device is under a manufacturer's warranty it cannot be repaired by an outside agency and must be returned to the school in order for a job to be logged with the manufacturer.
- 4. While the laptop is being repaired a temporary hire laptop will be provided to ensure the student's learning is not impacted.
- 5. Once the damaged device is repaired it will be returned to the student upon the return of the temporary hire laptop.
- 6. Once the school receives the invoice for the repairs from the manufacturer, the student's account will be invoiced and a letter sent home to parent/caregiver.
